IF A RACING VEHICLE, PLEASE FOLLOW INSTRUCTIONS FOR TEMPORARY EPA RACING VEHICLE EXCLUSION. IF APPROVED BY THE EPA, YOU WILL RECEIVED AN APPROVAL CERTIFCATE WHICH MUST BE PROVIDED TO DIRECT EXPRESS, INC.

IF ALTERING A VEHICLE, PLEASE FOLLOW INSTRUCTIONS FOR EPA TEMPORARY IMOPRT FOR ALTERNATIONS. IF APPROVED BY THE EPA, YOU WILL RECEIVED AN APPROVAL CERTIFCATE WHICH MUST BE PROVIDED TO DIRECT EXPRESS, INC.

IF YOU ARE A NON RESIDENCE, PLEASE FOLLOW THE NON-RESIDENCE EPA TEMPOERARTY IMPORT INSTRUCTIONS. IF APPROVED BY THE EPA, YOU WILL RECEIVED AN APPROVAL CERTIFCATE WHICH MUST BE PROVIDED TO DIRECT EXPRESS, INC.
